

15/30 YEAR LIMITED WARRANTY



The factory-applied Diamond Kote™ finish is warranted to the original property owner for a period of thirty (30) years from the date of purchase from the retailer/dealer. With normal care when subject to usual weather conditions, the finish is warranted not to:

- Discolor due to chalking
- Peel or blister
- Erode and expose the substrate
- Discolor due to yellowing
- Discolor due to excessive fade

LIMITATIONS:

The Diamond Kote™ finish is not warranted against damage of any kind caused by air pollution, mildew, exposure to harmful chemicals or normal weathering resulting from exposure to the elements. This finish is warranted against excess fade beyond normal weathering. Excess fade is defined by a change in color greater than three (3) delta E's. In the event the Diamond Kote™ finish is found defective of the specified conditions listed above, Wausau Supply Company will:

1. Provide \$0.25 per square foot for coating materials to recoat the areas validated as defective of the specified conditions listed above.
2. During the first seven (7) years following the date of purchase, Wausau Supply Company will provide for the application of the coating material limited to a total cost of not more than \$1.25 per square foot for areas validated as defective of the specified conditions listed above.
3. From year eight (8) through year fifteen (15), application costs will be prorated; each year the amount paid per square foot will be reduced per the schedule below.

Year 8 - 85% or \$1.07 per square foot

Year 9 - 75% or \$0.94 per square foot

Year 10 - 65% or \$0.82 per square foot

Year 11 - 55% or \$0.69 per square foot

Year 12 - 45% or \$0.57 per square foot

Year 13 - 35% or \$0.44 per square foot

Year 14 - 25% or \$0.32 per square foot

Year 15 - 15% or \$0.19 per square foot

Year 16-30 - No application cost coverage, material only at \$0.25 per square foot

The one-time surface recoating must occur within the Warranty period based on the date of purchase and only if the Diamond Kote™ coated product has been properly stored, installed and handled according to label directions and under normal conditions and exposure.

This warranty does not cover defects caused by acts of God, such as: tornado, hail, hurricane, earthquake, flood, lightning, fire, damage caused by foreign objects, any abuse or misuse, improper handling during storage and transportation, improper installation or damage caused by being installed.

This warranty does not cover cracking, peeling or blistering resulting from: the product becoming wet prior to installation, moisture exposure to the uncoated surfaces of the product after installation, improper ventilation, expansion and contraction, breakdown of the underlying substrate, surface deterioration due to pollution, abrasion, salt exposure, misuse, vandalism, mildew accumulation, or any introduction of moisture into the product prior to and during the installation of the product.

This warranty is limited to SmartSide® Lap Siding, Panel Siding, Trim & Fascia, and Soffit ("the Product(s)") installed on structures permanently located in the United States and Canada.

1. Warranty Coverage—Limited 50-year Substrate Warranty Louisiana-Pacific Corporation ("LP")'s warranty is made to the original purchaser of the Product(s) ("Purchaser"); the original owner of the structure on which the Product(s) are installed; and to the next owner of that structure (together "Owner"). LP's express warranties may not be assigned to any subsequent owners of the structure. LP warrants that the Product(s) will remain free from: a) fungal degradation; b) buckling and c) cracking, peeling, separating, chipping, flaking or rupturing of the resin-impregnated surface overlay for a period of 50 years from the date application is completed, when the Product(s) has been stored, handled, applied, finished and maintained in accordance with LP's application, finishing and maintenance instructions in effect at the time of application.

LP SmartSide Precision Series 38 Series lap and panel siding product(s), LP SmartSide Precision Series 76 Series panel product(s), LP SmartSide Architectural Collection 120 Series lap product(s), LP SmartSide Foundations 76 Series lap product(s), LP SmartSide Foundations 120 Series panel product(s), LP SmartSide Foundations 120 Series Stucco and Reverse Board and Batten panel product(s) are warranted against buckling when installed up to 16 in. o.c. stud spacing and when stored, transported, handled and maintained in accordance with applicable LP SmartSide Application Instructions. Buckling is defined as 1/4 in. out of plane covering a distance no greater than 16 in. between studs. Waviness due to misaligned framing, crooked or bowed studs, foundation or wall settling, or improper nailing is not considered buckling. THIS WARRANTY DOES NOT COVER PERFORMANCE OF 76 SERIES FOUNDATIONS SIDING IN ALASKA, BRITISH COLUMBIA, HAWAII, NORTHERN CALIFORNIA NORTH OF I-80 OR WEST OF THE CASCADES IN WASHINGTON, OREGON AND CALIFORNIA. THIS WARRANTY DOES NOT COVER FOUNDATIONS OR ARCHITECTURAL SERIES PANEL SIDING WHEN USED IN PREFABRICATED OR MANUFACTURED HOUSING.

LP SmartSide Precision Series 76 Series lap siding product(s) and LP SmartSide Precision Series 190 Series panel product(s) are warranted against buckling when installed up to 24 in. o.c. stud spacing and when stored, transported, handled and maintained in accordance with applicable LP SmartSide

Application Instructions. Buckling is defined as 3/8 in. out of plane covering a distance no greater than 24 in. between studs. Waviness due to misaligned framing, crooked or bowed studs, foundation or wall settling, or improper nailing is not considered buckling.

LP further warrants that the Product(s) have been treated with the borate-based SmartGuard® process during their manufacture to enhance their ability to resist structural damage due to termites and fungal decay.

2. Remedies for Breach of Limited Express Substrate Warranty THIS SECTION 3 PROVIDES THE SOLE AND EXCLUSIVE REMEDY AVAILABLE TO A PURCHASER OR OWNER OF A STRUCTURE ON WHICH PRODUCT(S) HAS BEEN APPLIED.

In the event of a breach of this Limited Express Warranty (or of any implied warranty not otherwise disclaimed herein), LP will:

- a) during the first 5 years from the date of installation, pay an amount equal to the cost (as established by an independent construction cost estimator, such as R. S. Means) of repairing or replacing any Product(s) that fails to comply with the provisions of Paragraph 1, above, or
- b) during the 6th through the 49th years from the date of installation, pay an amount equal to the cost of similar wood based replacement product, (no labor or other charges shall be paid) less an annual pro rata reduction of 2.22% per year (6th year, 2.22%; 7th year, 4.44%, etc.) such that from and after the 50th year the amount payable under this warranty will be zero.

Any dispute concerning the applicability of the warranty or whether the Product(s) met the manufacturer's standards in accordance with Paragraph 1 shall be submitted to binding arbitration under the Commercial Arbitration Rules of the American Arbitration Association. The jurisdiction of the arbitrator over the dispute shall be exclusive and the decision of the arbitrator shall be binding and non-appealable.

The RigidStack™ siding, RigidMount™ mounting blocks, shakes and trim components that make up the Wausau Siding Systems™ are warranted to the original purchaser/property owner for a period of fifty (50) years from the date of purchase from the retailer/dealer. With normal care when subject to usual weather conditions, proper handling and installation of the product is warranted not to:

- Separate at the joints (not to exceed .125")
- Separate from the nailing flange
- Separate from the spline

LIMITATIONS

The product is not warranted against damage of any kind caused by air pollution, mildew, ice or water, or exposure to harmful chemicals or normal weathering resulting from exposure to the elements.

In the event the Wausau Siding Systems™ product is found defective of the specified conditions listed above, Wausau Siding Systems™ will:

1. Provide replacement material for the areas validated as defective of the specified conditions listed above.
2. During the first five (5) years following the date of purchase, Wausau Siding Systems™ will provide labor reimbursement for the re-installation of the product limited to a total cost of not more than \$2.00 per square foot for siding and shakes and \$4.00 per lineal foot for trim.
